GENERAL RULES

1. Sponsors shall not be held responsible for any damage or losses to such property during the show. All show day announcements take precedence over previous announcements.

2. All animals will be shown as prospects, not finished animals.

- 3. Show committee shall, upon completion of the official weigh-in, determine classes for the event.
- 4. The decision of the judge will be final.
- 5. All exhibitors will be required to keep their stalls clean of trash or litter & place it in the designated area.

6. All animals \$8 head not to exceed \$24 per exhibitor or \$40 per family - <u>Pre Entries due May 5th</u>. Late entries (received after May 5th) \$12 head not to exceed \$36 per exhibitor or \$60 per family. **Make checks to the Comanche County 4-H Council**

7. Only bona fide 4-H & FFA members are eligible. (Age as of Jan 1, 2017) PeeWee showmanship (5&6 yr olds, \$5 fee) will be given a participation award only.

8. Comanche Co. 4-H Council reserves the right, to remove from the grounds any exhibitor, animal or person that may be deemed objectionable.

9. All lambs/goats must be free of club lamb fungus and sore mouth, or the show committee will dismiss the lamb.

- 10. Any Exhibitor may enter as many exhibits as he/she wishes and must own them.
- 11. <u>Everyone will be asked to provide their own bedding and clean-up their own bedding.</u> Showing out of your trailer is encouraged.
- 12. This show is "Blow & Show". Paint, glue and adhesives will not be allowed.

13. Meat Goats, Sheep & Swine will be weighed from 7:00 a.m.—8:00 a.m. <u>cards due by 8:00 a.m.</u> Cattle will be weighed by individuals 9:30 a.m.—10:30 a.m. and <u>weigh cards due at 10:30</u>. Animals may be subject to weigh back. <u>EVERY ANIMAL NEEDS A WEIGH CARD</u>, breeding animals don't need a declared weight but DO need a card.

14. To show in showmanship the animal must be owned by the exhibitor and shown in a prospect class.

15. No entries accepted after completion of weighing.

16.Exhibitors are expected to respect and meet Kansas Animal Health Requirements. Please consult your local Vet.

17. No intact males, except for bucket calves.

18. Weigh-backs will be used if deemed necessary.
